(*The list MUST be in the order you wish to purchase.*) A partial payment of 25 percent of the combined value of desired certificates as of July 1, 2025, must be paid by the deadline as one payment, separate from Priority Certificates and Registration Fees. For each Current-year Certificate, provide the following information:
  - a. County map/parcel number
  - b. Tax bill number
  - c. Year of tax bill
  - d. Taxpayer name

**STATE REGISTRATION**

All third-party purchasers who meet any of the following conditions **MUST** register with the Kentucky Department of Revenue and provide the Certificate of Registration to the County Clerk before being allowed to purchase tax bills:

- Plans to purchase more than three (3) Certificates of Delinquency in any county.
- Plans to purchase more than five (5) Certificates of Delinquency statewide.
- Plans to invest more than \$10,000.00 statewide in any calendar year.

If a third-party purchaser has questions about the registration process at the state level, they can access the Department of Revenue’s website [Revenue.ky.gov](http://Revenue.ky.gov). After selecting the “Property Tax” link they will be able to obtain the most up-to-date information as well as download an application form.

**BANKRUPTCY ISSUES**

Third-party purchasers should do their own Bankruptcy Filing Research before purchasing Certificates of Delinquency. A subscription service known as “PACER” may be utilized by third-party purchasers to get up-to-date information about bankruptcy filings. Visit [PACER.uscourts.gov](http://PACER.uscourts.gov) to obtain more information about this service.

**TAX BILL LIST**

Current-year tax bills may be viewed on Crittenden County Clerk’s website at [crittenden.clerkinfo.net](http://crittenden.clerkinfo.net) at least 30 days prior to the tax sale and in The Crittenden Press in the June 19, 2025, edition. Some bills listed will not be available for purchase.

**TAX SALE PROCEDURE**

The tax sale will begin at 9 a.m. CDT on Wednesday, July 23, 2025, in Crittenden County Clerk’s Office at 200 Industrial Dr., Marion, Ky. The sale will be conducted like a sports draft, with each purchaser having the opportunity to purchase one certificate at a time through several rounds until all purchases are complete. Lots will be drawn for order of selection. A representative **MUST** be present to purchase certificates at the tax sale, but one person may represent multiple purchasers.
